Dear Parents, Students and Friends of St. Narsai's College

The College has been collaborating with an external provider to upgrade its website and I am pleased to report that we are getting close to launching the new website soon. In the meantime, parents can now have easy access to several important college policies via the current college website. Dear Parents and Friends

As we enter the last week of term, I wish all students an enjoyable and restful break from routine over the next two weeks. Students have had a busy term of learning this term and should be proud of their efforts. It has been another busy term of learning achievement, Cross Country, Athletics Carnival, NAPLAN exams and sporting team competitions amongst other school events and extracurricular activities.

COVID-19 Precautionary Measures

In light of the current COVID outbreak, masks are required in public spaces, indoors and on public transport. To maintain the health and safety of all students, we continue to maintain precautionary measures including:

- -Hand sanitisers are available to all students
- -All visitors to the site must continue to sign in
- -Students that are unwell are asked to remain at home. If students appear with flu like symptoms, parents will be contacted, and a medical clearance is required on the students return to school.
- -Students and staff are encouraged to wear face masks in indoor settings

Years 7-11 Reports and Parent Teacher Interviews

Semester One Student Reports will be distributed on this day. The day is a pupil free day and students are not required to be at school unless accompanied by their parent/guardian for an interview.

The interviews will be held in a COVID – safe environment. All parents must register for appointments prior to the date. On the day, parents will be required to sign in using the QR code on entry to the school. If you are feeling unwell, please call the school to reschedule your interviews.

HSC Trial Examinations

Year 12 Trial Examinations will commence on Monday 26th July and conclude on Monday 9th August. All students will return to normal classes on Tuesday 10th August. Students have been given a timetable of exams and should be prioritising their studies based on the timetable. For many students, the trial exams are the last formal exam before the HSC exams and a general indication of what the final HSC exam structure will be. Parents are encouraged to speak to their child about their study timetable leading up to the exams.

Attendance and Punctuality

Parents are reminded that all students must attend school everyday. If you're child is unwell and needs to stay home, please ensure that a letter explaining the absence is given to the office on the day of their return. You can also email the reason for their absence to our school office info@stnarsai.nsw.edu.au.

Students are required to be at school by 8.25am. Students that arrive well before the bell rings are better prepared for the day. Students that arrive late will receive detentions followed by an after school detention for their third lateness.

Chewing gum

Parents and Students are reminded that chewing gum is not allowed at the school. Students caught chewing gum will receive a detention and an invoice may be sent home to cover the costs of cleaning.

Year 11 2022 Subject Selection

The subject selection process for Year 11 2022 will commence in Week 2 next term, with an information session for all Year 10 students and their parents. More details on the Subject Selection process will be sent to parents in Week 1 of Term 3. In the meantime, I encourage parents to discuss with their child the subjects that they are considering on studying.

Minimum Standards tests for Years 10, 11 and 12 students

All students in NSW will need to demonstrate a minimum standard of literacy and numeracy to receive their HSC. The HSC minimum standard is part of an effort to improve the literacy and numeracy outcomes for students.

The HSC minimum standard is a way of supporting and ensuring students have a functional level of literacy and numeracy. The HSC minimum standard is set at Level 3 of the Australian Core Skills Framework which outlines the functional skills used in everyday life, for work and further study. This framework provides detailed information on the three areas in which the students will be tested: Reading, Writing and Numeracy.

All students must sit the minimum standards tests. The student must achieve a level 3 in each test. This aligns with level 3 of the Australian Core Skills Framework (ACSF) which is considered the level required to function in everyday life, for work and further study.

To achieve their HSC, all students must sit the HSC minimum standard online tests in reading, writing and numeracy. Each of the three tests are of 45 minutes duration. The writing test consists of a response of up to 500 words to one written or visual prompt, and the other two are 45 multiple choice questions.

Students have 4 attempts at each test throughout the year. Once they meet the minimum standard, they are not required to sit the test again. We will schedule the test sessions in each term to allow students the maximum attempts that they need per year.

To prepare for the tests, students can complete the online practice tests at school using their Schools Online account as many times as is practicable. Once the HSC minimum standard is achieved in all three areas, a student is eligible to receive the HSC. Having students attend school punctually and ready to sit the test will be very much appreciated by the team of staff involved.

Students can access their minimum standard test results through their Schools Online account. They can also print a minimum standard report that clearly shows the level (1-4) that they achieved in the test. Level 3 is the minimum standard.

What have the Creative and Performing Arts department been up to in Term 2?

Year 7 Seletive Stream Music

This term in Yr 7G Music has been taught and assessed on their piano skills, we were assessed on two songs of your choice, one with left hand and the other with your right. We were taught with the Piano booklets our teacher gave us and it help with progress. Near the end of the term we knew all of the keys and how to play a variety of songs. After learning piano, we started reviewing Instruments of The Orchestra, we learned all the different families and instruments that go in the four families. We listened to the recordings of instruments played in an orchestra and wrote the family, pitch and tone colour beside them. We were also taught about treble and base clef and the notes that go onto the ledger lines depending on the clefs. We were then later assessed on the instruments of the orchestra and other topics we have studied this semester in our half yearly exam. Overall 7G music has enjoyed the practical lessons, as well as the theory lessons and understood the different topics that were taught and assessed this term.

Year 9 music

This term in music, we have learnt various musical structures (sections) that are found within songs and pieces of music. We have specifically focused on verse chorus, which makes up the structure of many pop songs. The class has been preparing personal performance pieces to help strengthen our understanding of the Pop musical genre and apply the Concepts of Music into our performance. Throughout the term, our class has done various practical activities in conjunction with the analysis of multiple pop songs to help get the best mark possible.

Year 10 Music

This term in Year 10 Music we have been learning about Popular music and the Concepts of Music. We have been developing our performance skills by working to play in small bands and also trying to perform on different instruments we wouldn't normally play as our main instrument. For our half yearly exam we focused on Aural skills and identifying particular sounds that were played to us.



Year 11 Music

This term in Year 11 Music, our class has been learning about Small Ensembles, which are small groups of musicians playing a piece together. Through this topic we have further developed a thorough understanding of what a small ensemble is, how the instruments in each ensemble work to complement each other, and have used these features to analyse the piece, using the Concepts of Music to do so. The other component to our assessment task of this term was a composition, which is a small song that each person in our class has written, played, and produced with their partner. Working in small groups for our composition has enabled us to expand our knowledge of how small ensembles work, assisting us in completing our other task.

HSIE FACULTY


Dear family and friends of the college community,

HSIE consists of two subjects; History & Geography. In the past two terms of year 8 we have studied History. I have learnt about the past societies and periods such as Medieval Europe, Modern times AD c.1500, Medieval times AD 500-AD c.1500, Ancient times 3000 BC-AD c.500 & Prehistory before 3000 BC. LEARNING SUPPORT UNIT



Dear parents, guardians and carers,

Re: Nationally Consistent Collection of Data on School Students with Disability (NCCD)

Every year, all schools in Australia participate in the Nationally Consistent Collection of Data on School Students with Disability (NCCD). The Learning Support Unit at St Narsai Assyrian Christina College will be collecting this data in the next few weeks. The NCCD process requires schools to identify information already available in the school about supports provided to students with disability. These relate to legislative requirements under the Disability Discrimination Act 1992 and the Disability Standards for Education 2005, in line with the NCCD guidelines (2019).

Information provided about students to the Australian Government for the NCCD includes:

- year of schooling
- category of disability: physical, cognitive, sensory or social/emotional
- level of adjustment provided: support provided within quality differentiated teaching practice, supplementary, substantial or extensive.

This information assists schools to:

- formally recognise the supports and adjustments provided to students with disability in schools
- consider how they can strengthen the support of students with disability in schools
- develop shared practices so that they can review their learning programs in order to improve educational outcomes for students with disability.

The NCCD provides state and federal governments with the information they need to plan more broadly for the support of students with disability.

The NCCD will have no direct impact on your child and your child will not be involved in any testing process. The school will provide data to the Australian Government in such a way that no individual student will be able to be identified – the privacy and confidentiality of all students is ensured. All information is protected by privacy laws that regulate the collection, storage and disclosure of personal information.
